## NOTICE OF ANNUAL MEETING OF THE POLISH & SLAVIC FEDERAL CREDIT UNION AND ELECTION PROCEDURES

#### TO THE MEMBERS OF THE POLISH & SLAVIC FEDERAL CREDIT UNION

Please be advised of the following:

The Polish & Slavic Federal Credit Union's Annual Meeting will take place on Sunday, June 1st 2008 at 2:00 p.m., at Polish National Home, 261 Driggs Ave., Brooklyn, New York. At this meeting, the results of the annual election, conducted and tabulated by the Election Services Corporation (an independent firm not affiliated with PSFCU) will be reported to the membership. Due to the expiration of the terms of four directors, four seats on the Board of Directors will be available. The four candidates who receive the highest number of votes cast will serve three-year terms.

A list of the candidates was posted in all branch offices of PSFCU on Sunday, April 27th, 2008. The ballots were mailed on Thursday, May 1st, 2008. The deadline for the Election Services Corporation to receive all votes is Tuesday May 27th, 2008 by 11:59 p.m., EST.

The following individuals are candidates for the Board of Directors in the Election of 2008 (*Names are in alphabetical order*):

**Voting Instructions:** The 2008 PSFCU Elections will be conducted by paper ballot with optional electronic voting. The electronic voting will be available only to those PSFCU Members who are registered Online Banking users. If both votes are received, first to arrive counts. Voting instructions are outlined below:

VOTING BY MAIL: ■ Sign the Validation Certificate on the reverse side. Your ballot cannot be counted if you do not sign your name in the box provided. ■ Cast your vote using the ballot. Mark your choice(s) by placing an X or ✓ in the appropriate box(es). Do not write your name or otherwise identify yourself on the ballot. ■ Detach the Validation Certificate from the ballot. ■ Fold your ballot in half, then fold the "Tape Here" flap over and tape or glue where indicated. Do not staple. ■ Insert the Validation Certificate and the sealed ballot in the prepaid return envelope provided.

**ELECTRONIC VOTING:** Log-in to your Online Banking account at www.psfcu.com to obtain your Voting Code for 2008 located on the Account Summary page under address line. Go to https://www.esc-vote.com/psfcu to access the secure voting site log-in page. Elenter your 6-digit Voting Code For 2008 and 10-digit Election Validation Number (located in the bottom right corner of the ballot) to access the electronic ballot. Cast your vote.
