Dear Members,

August is a special month in Poland's recent history. 73 years ago, on August 1, 1944, the inhabitants of Warsaw took up arms to liberate their city from German



occupation. Despite the military defeat, their heroism will remain in our nation's memory forever. The Polish & Slavic Federal Credit Union and the Polish community in Greenpoint celebrated this event by solemnly raising a flag with an anchor, the symbol of insurgent Warsaw, on the flagpole in front of our headquarters in Brooklyn. A similar flag is waving in front of our branch in Bridgeview, IL for 63 days.

August 15 is the anniversary of one of the most important battles of the 20th century, also known as the "Miracle on the Vistula". In 1920, the Polish army stopped the Bolshevik onslaught seeking to take Europe by storm.

On August 31, 37 years passed since the signing of the August Agreements that began the destruction of communism in Poland and then in Europe.

Neither can we forget about September 1, 1939, when Nazi Germany started World War II by attacking Poland. I invite you to follow our pages in the social media, where we recall all of these important events in Polish history.

Even though it was vacation season, the PSFCU actively continued its commitment to the Polish community. From the beginning

### **PSFCU** Commemorates Warsaw Uprising Fighters

On the exact anniversary of the "W" hour, on August 1 at 11:00 a.m. Eastern time, the white-and-red flag with an anchor, the symbol of Fighting Poland, was raised on the flagpole in front of headquarters of the Polish & Slavic Federal Credit Union ,in Greenpoint. For 63 days it will wave in the New York sky in honor of the participants and victims of the Warsaw Uprising. An identical flag with the symbol of Fighting Poland was raised in front of the PSFCU branch in Bridgeview in the southern suburbs of Chicago.

The flag was raised by Tadeusz Antoniak, member of the Polish Army Veterans Association of America (PAVA) and Chairman of the Smolensk Anniversary Observance Committee of Pennsylvania, accompanied by the sounds of fire sirens and the engines of the Harley-Davidson motorcycles driven by riders from the Polish "Unknown Riders" club who came for the ceremony. The attendees included Wladyslaw Mazur, who participated in the Uprising, and Antoni Chroscielewski, the Commander of the New York Post of PAVA, a soldier of Gen. Anders Army and a participant in the Battle of Monte Cassino. Also present at the ceremony were scouts, members of PAVA and other Polish community organizations, PSFCU employees and Greenpoint residents.

"Seventy-three years ago, Warsaw residents took up arms to achieve their dream of a free Poland," said Bogdan Chmielewski, Chief Executive Officer of the Polish & Slavic Federal Credit Union. Mr. Chmielewski reminded those present that today Poles, "no matter whether they live in Poland or have emigrated," must "learn a lesson" from the events 73 years ago. "First of all, we have to always remember these heroes and our meeting today is doing just that. Secondly, we must draw conclusions from this tragic story: Poles must always be

together, united. Thirdly, we can never again allow Poland to be occupied and enslaved," Mr. Chmielewski said.

Maciej Golubiewski, Consul General of the Republic of Poland in New York, spoke during the ceremony. "After the war, many of the insurgents went to live abroad, including the United States. One of them was a Commander in the Uprising, Gen. Antoni Chrusciel, code-named "The Fitter", who was buried in the friendly ground of the American Czestochowa, and 44 years later his remains were taken to Poland. After

73 years, few of us participants remain among us. That is why today I would like to pay tribute to all the living and deceased for their fight for freedom and their heroic courage," said Consul Golubiewski.

This is the second year in a row that the flag with the symbol of Fighting Poland will be waving in front of the headquarters of the Polish & Slavic Federal Credit Union. Like the flag raised in front of the PSFCU branch in Bridgeview near Chicago, for 63 days it will remind us of the heroism and tragedy of the Warsaw Uprising.

The creator of the Polish Cooperative Savings & Credit Unions (Polish SKOK), Senator Grzegorz Bierecki, received a Distinguished Service Award for his outstanding achievements in the world credit union move ment. This recognition is for his many years of activity promoting the financial coope rative concept worldwide.

Senator Bierecki received the award at the annual meeting of the World Council of Credit Unions (WOCCU) in Vienna. It is the highest form of recognition of the WOCCU, awarded for his "special contribution to the promotion of the credit union movement outside his own country". Senator Bierecki was one of four people and organizations so honored in 2017. You will recall that Senator Bierecki was the Chairman of the WOCCU in 2013-2014. Entrusting him with this office was a tribute to the unprecedented

success of Polish credit unions over the last two decades, as they developed under extremely difficult legal and business conditions. "I am a Pole and I feel proud of my origin," stated Senator Bierecki just after his election to the WOCCU chairmanship. "Everything that we did when founding Cooperative Savings & Credit Unions in Poland, we did in continuation of the mission initiated by "Solidarity". We did not expect any prize then, all we were concerned about was the welfare of society.

Over 1,600 delegates from 58 countries attended the annual meeting of the World Council of Credit Unions this year. For three days in Vienna in July, they discussed the latest trends and technological developments in the financial sector and ways to increase the membership of young people in credit unions.

## Watch Out For Fraudulent Checks!

Does this scenario seem familiar? You are trying to sell a large item online (e.g. through Craigslist). You are contacted by a prospective buyer who sends you a check in the amount much higher than that of the sale, asking you at the same time to immediately send the balance of the money by MoneyGram or Western Union to a "shipping service" which is already on the way to pick up your item.

Or, you answer an online ad for a dream job. You are asked to "take care" of a house of a family moving to the United States from overseas. You receive a check for a large amount of money and a letter instructing you to deposit it to your account, deduct your weekly salary from it and deposit the balance to a "case manager's" account at a different financial institution.

In both cases, the most likely result will be the same – you will have complied with the instructions and paid your hard-earned money only to find out later that the original check was fraudulent and returned unpaid.

These are only a couple of scenarios that fraudsters employ to elicit money from unsuspecting victims. If you are ever faced with a similar situation, first and foremost make sure to protect yourself. Take the time to verify the offer, see if you can contact the bank the check was drawn on to verify whether there are sufficient funds to cover it. If you have any doubt whether the check is legitimate, do mention it to our teller and request a longer hold of at least 5-7 business days to minimize the risk of check being bounced. Be careful with sending or depositing money into anyone's account if you are asked to do so before you are absolutely sure the check was properly verified.

Remember, that if the check you have just deposited bounces, you will be responsible for the negative balance and will be subject to collection, as you would be with any other credit.

And first and foremost, remember that if an offer you receive sounds too good to be true, it most probably is.
