Dear PSFCU Members.

This year, our Credit Union is celebrating its 45th anniversary. On September 30, 1976, the founding act of the Credit Union was



signed by eight Polish immigrants centered around Reverend Longin Tolczyk. In a series of articles in the coming months, we will provide some insight into the history of the creation and growth of our Credit Union, because it is also the story of a huge collective success of the Polish-American community, and also contributed to many individual successes of our members. The beginnings were undoubtedly very difficult and none of the founders probably expected that the institution they founded in 1976 would grow to such a size and would play such a key role in the lives of Polish-Americans. Starting with one desk in the corner of a Greenpoint canteen, 45 years later we have over \$2.5 billion in assets, almost 108,000 members and 21 branches located in four states: New York, New Jersey, Illinois and Pennsylvania. We are the largest ethnic credit union in the United States and the largest Polish financial institution outside of Poland. Let us remember all those people whose vision and actions contributed to the creation of our Credit Union, because we, as the current generation of Polish-Americans, owe them a lot.

During the September visit to New York on the occasion of the annual session of the United Nations General Assembly, President of the Republic of Poland Andrzej Duda and the First Lady of the Republic of Poland Agata Kornhauser-Duda met with the Polish community in Linden, New Jersey.

"Poles in the United States have done a great deal for Poland over the past decades.

This is not only a question of giving a good testimony to the Americans, but also involves many other very important aspects. we can buy the most modern equipment in the United States," Andrzej Duda said in Linden. During the meeting, the Polish President also presented Malgorzata Czajkowska, Secretary of the PSFCU Board of Directors, with the medal of the 100th Anniversary of Polish Independence.

Two days earlier, on September 21, the First Lady of the Republic of Poland, Agata Kornhauser-Duda, visited PSFCU headquarters in Greenpoint. "I would like to thank the Polish & Slavic Federal Credit Union for supporting so many charities. Especially for supporting sick children and hospices in Poland. I must say that these institutions are extremely grateful because I do visit them and I know how important this assistance is to them," said the First Lady during a meeting with the management and employees at the PSFCU headquarters in New York. She was accompanied by the Secretary of State at the Chancellerv of the President of the Republic of Poland, Minister Adam Kwiatkowski and by Consul General of the Republic of Poland in New

York, Adrian Kubicki.

After the meeting with PSFCU management and employees, the First Lady welcomed 21 representatives of the Polish community from the East Coast of the U.S., who have demonstrated extraordinary commitment to helping people in need (the elderly, the sick, the lonely) during the COVID-19 pandemic. "For me, all of you are heroes because you risked your own lives and health to help others," said Agata Kornhauser-Duda.

The guests invited to the meeting with the First Lady included: Agata Drogowska and Malgorzata Gruszecka (Polish Filmmakers NYC), Marek Wojcik (owner of the "Brand Pharmacy" in Greenpoint), Sławomir Letowski (owner of "Karczma" restaurant in Greenpoint), Frank Semczyk (head of Pete McGuinness Senior Center), Eryka Volker (organizing help for the homeless through SOS Homeless), priests: Grzegorz Stasiak and Łukasz Kleczka (Bayonne, NJ parish), Anna Kobylarz (organizing help in New Britain, Connecticut and the surrounding area) and representatives of the We See You Foundation (Marta Deren, Maria Kosiec, Barbara Trzcinka). The Polish & Slavic Federal Credit Union financed charitable assistance during the worst period of the COVID-19 pandemic in 2020 through a special assistance fund, which amounted to 226 thousand dollars.

In connection with the 45th anniversary of the foundation of the Polish & Slavic Federal Credit Union, which falls this December, we would like to introduce you to the history of our Credit Union in subsequent editions of our newsletter. In this issue: PSFCU foundation and first years of operation.

PSFCU was established in 1976 by Polish activists from New York's Greenpoint, centered around Reverend Longin Tolczyk. The Credit Union's aim was to help immigrants from communist Poland who did not have a credit history and were coming to New York. As a result, American financial institutions did not want to grant them loans for the purchase and renovation of real estate in the then neglected district of Greenpoint.

On December 27, 1976, federal National Credit Union Administration (NCUA) chartered the Industrial and Commercial Federal Credit Union. The founding document was signed by Rev. Longin Tolczyk, Rev. Emil Altmajer, Marek Luniewski, Jan Raczkowski, Jozef Waltos, Jerzy Wolinski and Halina Zołnierowicz. In 1979, the previous name was changed to the Polish & Slavic Federal Credit Union, which remains in use to this day.

PSFCU Origins and First Years

In the early years, Greenpoint was the only place of operation of our Credit Union. The first office - actually one table where the employee sat - was in a canteen for immigrants located at 931 Manhattan Avenue. As New York's "Polish Daily News" wrote at the time, "the incredible success of this social initiative exceeded the expectations of even the greatest optimists. The place (...) was teeming with activity. The local Polish community was not discouraged by modesty, even more than mere modesty, of the Credit Union's room - there is a lot of traffic every day."

In May 1978, Polish Daily News wrote about the deposited savings: "One Million Dollars in a Year and a Half". In January 1979, our Credit Union purchased a building at 140 Greenpoint Avenue, which, after renovation, became its headquarters in 1981 (today it houses the oldest Greenpoint branch of the PSFCU). After two years of operation, it became clear that the PSFCU was a success. "Credit Union members provide an example that the money they deposit in a Polish bank serves only the good of the Polish ethnic group" noted Polish Daily News in February 1979.



PSFCU VISA® Card Rewards Programs

Rewards programs are a great way to maximize your profits when making everyday purchases. CU Rewards

CU Rewards is a rewards program offered to holders of certain PSFCU VISA[®] credit cards. Premier and Liberty cardholders participate in a program where the cardholder receives one rewards point for every dollar spent. However, it is worth remembering to check the special offers on the program's website - www.curewards.com. You can find some special offers there, which will allow you to get even 10 or more points for one dollar spent. Collected points can be used to purchase attractive products or travel services.

Cash rewards

If you want a particularly attractive loyalty points program and cash rewards, the Elite VISA® Signature credit card is the natural choice. By using this card, CU Rewards will earn you 1.25 rewards points for every dollar spent on a purchase. If you do not have the Elite VISA® Signature card yet, you will receive additional 5,000 points if you spend \$1,500 in the first three months of card ownership. Unlike Premier and Liberty cards, you can also redeem your points for cash, which you can either transfer into your account or use to pay off your credit card bill.

Debit Card uChoose Rewards

Rewards points can also be collected using a PSFCU debit card. By enrolling in the uChoose Rewards program,

PSFCU VISA[®] debit cardholders will be awarded 1 point for every \$2 spent. Additionally, program members will be eligible for exclusive offers/promotions while earning as many as 10 points for each \$1 spent! All you need to do is take advantage of the current list of offers and participating vendors listed on the program website - www.uchooserewards.com.

The program also allows you to combine several cards (for example, cards of both spouses) on the same rewards account. The only condition is that the cards are of the same type, i.e. you cannot combine personal debit cards with business debit cards. Points will be awarded for signature transactions made using a registered debit card and additionally when making purchases in participating stores, either in person or online.
